STUDENTS RECEIVE INDIVIDUAL LESSONS AND GROUP CLASSES ON ALL INSTRUMENTS AND VOICE. INSTRUMENTS ARE PROVIDED TO THOSE WHO CANNOT AFFORD ONE. SOUNDS ACADEMY STUDENTS LEARN THE CHARACTER VALUES OF CREATIVITY, LEADERSHIP, PERSEVERANCE, RESILIENCE, AND TEAMWORK THROUGH MUSIC EDUCATION.
